Kotla Kalan, Tehsil & District Una, Himachal Pradesh-174303," for 10+1 & 10+2 (Science, Commerce & Arts Streams only) classes from the academic session 2021-22 (if the affiliating Board find fit) is conveyed subject to the following terms and conditions:-

That the school concerned shall be affiliated Central Board of Secondary Education Shiksha Kendra-2, Community Centre, Preet Vihar, Vikas Marg, Delhi,-110301, for 10+1 & 10+2 (Science, Commerce and Arts Streams only) classes.

That the State Govt, will not provide any type of financial assistance/Grant-in-aid etc. in respect of 2.

That the admission in the institution shall be made strictly in accordance with the norms as laid down by the Board of School Education to which the school is affiliated and no discrimination on the basis of easte, colour, creed and sex shall be made. No pupil shall be refused admission on 3.

That the private institution shall employ only the trained/eligible-staff as per the norms fixed by

That the fees and funds shall be such that they are not of exploiting nature but contribute to the spread of education. That the Manager shall, within six months after the end of the every Academic year, submit to the 16. competent authority the report of Chartered Accountant on the Audit of the Accounts under sub-17. That the concerned school will also not charge fee towards Building fund, Infrastructure fund and
